Public Comment-

James Brenza asked for clarification of the JEDD as a business owner and resident in Berlin Township he is concerned and interested in their overall direction for the JEDD. He also stated that in reading the Sunshine Law in Ohio regarding executive session use on page 111 it talks about for economic development it is solely for confidential business information of an applicant for economic development assistance so he is curious because he thought that involved the county economic development. He said this might come as a surprise but there isn't a high level of trust with them so he would like more clarity on why we are having discussions in executive session if it is actually with the county. O'Brien said if you read on G 8 the second part says "or to negotiations with other political subdivisions" and subdivisions would include city, villages, townships, the county and the state. Brenza asked if they were in active negotiations and that's why it is confidential. O'Brien said that's why it is allowed under the sunshine law. O'Brien said the advantages to a JEDD are it allows people who receive a benefit mainly those that get zoning and infrastructure to pay for it so the other residents don't have to pay for that, in fact they can pay for other businesses that are here. So if someone volunteers to pay it they will be the ones that pay the tax. He in visions that the ones new to the township would voluntarily paying the JEDD fees. Brenza asked if that was like the tax split they referred to in the past and O'Brien said people have referred to it, yes. He said we want to make sure we have an agreement so that we are not footing the bill for a developer. It should be the other way around, but we don't have an agreement. Brenza said he would reach out to O'Brien.
