Old Business -

Fairview Cemetery- Tim Foor wrote a letter to the trustees about some issues that have arisen with Fairview Cemetery and suggested some possible solutions. Bullard stated that a statement needs to be made as to what the township is specifically responsible for in regard to Fairview Cemetery, along with possible solutions to problems that are occurring. O'Brien suggested that the statement be given to the prosecutor to look over before it is made available to the public. D'Amico stated that the trustees will need to decide how much money is going to be spent on the ground penetrating radar, as Foor believes this is a necessity to be able to know exactly where things are located. Bullard stated that he is not opposed to spending the money for it, he just wants to make sure we are getting exactly the information that we need from it. O'Brien agrees and would like at least two quotes, if possible.

Disaster Plan, Password Policy- O'Brien stated that each of the new computers will have a password put on it and then all passwords will be put in an envelope and given to Smith. Employees will be able to change their passwords but Smith will be able to override it if ever need be. The computers should be in the first week of February. Bullard will work on the disaster plan.

Fulltime Fire Fighters- Pichert stated that they have four candidates that are interested in the position. The next step will be the physical ability test, which will be completed by mid-February. Pichert will give a status report after the physical ability test is given.

Piatt Road Updates- This will be discussed in executive session.

Trails and Recreation Committee- O'Brien stated that he wants the trustees to have a conversation before the committee is made, as he wants clarity in the purview and for it to have a sunset date. Bullard stated that he feels the committee's goals are to make recommendations to the trustees. Then the trustees will have to make decisions on any money spent or grants that may be applied for. Smith stated that there was not any money appropriated for it this year and that there is only \$2,255 in the park fund. Bullard will contact the prosecutor and come back with the framework in how to put the advisory committee together. Then jointly, the trustees will talk with residents and work to put objectives together for the committee.

JEDD- O'Brien stated that he has been working with John Albers, in regard to an MOU for the JEDD. At this point, O'Brien is not happy about where it is heading. O'Brien will continue to work on it.
